### **HOUSE COMMITTEE MINUTES**

# For June 13, 2016

### Minutes

## Standing Reports

Standing Administrator Reports were made for the Bar, Janitorial and Bingo functions. Kathy Miller presented Kitchen Information for Brandt.

<u>Bar/Janitorial</u> – Fajardo: The possibility of paying bartenders continues to be evaluated and remains an open issue.

Weekend janitorial service is an area of concern. Overall scheduling is being monitored and will be adjusted to stay within budget.

<u>Bingo</u> – Kathy Miller reported with Howe that it is going well, with COGS slightly high.

Kitchen – Kathy Miller reported for Brandt. Inventory is being managed and COGS is being monitored.

#### **Unfinished Business**

- Drink Pricing Review Trustee Fajardo reported review is complete. No further action is required.
- 2. Email notices of Lodge Communicatons Reed Simpson, in reply to ER Devore, stated we are in compliance with the Grand Lodge directive regarding notices to be sent or mailed to lodge members. Members receiving information electronically have indicated verifiable
